
To the Sevastopol Town Board of Supervisors:

**Whereas**, the Rules of Order for the Town Board permits the Chairman to appoint membership to Regular, Special and Ad-hoc Committees of the Town


**And whereas**, said Rules require the approval of such appointments by your honorable body
