Any groups, organizations or nonprofit using the concession stand and selling product is subject to \$100 concession stand rental fee. Organizations using the park facilities but not operating the concession stand for their benefit (i.e., Little League, Babe Ruth Leagues, etc.) are not subject to this fee.

Please park vehicles only in authorized areas. Parking is not allowed alongside the pavilion or on the grass areas. The back gate will be open for loading/unloading supplies and handicap access. Vehicles parked on the grass or left in the pavilion area will result in the forfeiture of your security deposit. Glass bottles are not allowed in the Town Park. Sorry, no pets.

SEVASTOPOL TOWN PARK PAVILION

4830 Ripp Road, located at intersection of Hwy. 57 & Ripp Road Approximately 5 miles North of Sturgeon Bay

Users have access to the pavilion, outside lights, and electric outlets. They can also reset any of the outside outlets circuit breakers if needed. There is a gray electrical box (labeled) located next to the small access door in the pavilion that will turn on the exterior lights and/or allow the users to reset the circuit breakers if needed for the external outlets. This box is not locked and is safe for user access. Please remember to turn off the lights if used.

Additionally, your reservations for the Park Pavilion includes a refundable (\$50.00) deposit. Pavilion users may use the round trash barrels adjacent to the pavilion for convenient disposal. Garbage can be left in those barrels. Park staff will dispose of garbage on Monday. There is a small side by side refrigerator/freezer for your use. Restrooms located at concession stand.

Please use back gate entrance for unloading/loading/handicap access. Parking is not allowed alongside the pavilion. A vehicle may unload but then must be returned to the parking lot.

The Town Clerk Treasurer will process the return of your security deposit after your event.
